## **Summary of Notice to Chief Constables**

- 1. The principal document is intended to put Chief Constables on notice of their obligation to uphold the rule of law I e English Constitutional Common Law
- 2. It sets out that Article 61 Magna Carta (**Exhibit A**) was successfully invoked via Barons' Petition (**Exhibit B**) on 23 March 2001 in response to the treason (an attempt to overthrow or usurp legitimate state governance) represented by the signing of the Treaty of Rome, surrendering English sovereignty to a foreign power (high treason and still punishable by death) (**Exhibit C**)
- 3. Treason was defined in the Treason Act 1571, which is still constitutional law (**Exhibit D**)
- 4. Conclusive evidence for the above treason can be found in a Foreign Commonwealth Office document: FCO 30/1048 available online
- 5. The Article 61 invocation placed all subsequent governments, their agents and officers in the position of committing treason by following and applying the rules of a treasonous regime
- 6. Churchill stated in 1956 that Magna Carta is a law which is above the King and Parliament. Our schools teach us that parliament is sovereign. It is not.
- 7. This Notice reminds Officers that ignorance of the Law is no defence
- 8. Equally, no man or woman is above constitutional common laws and customs
- 9. We the people are now unequivocally voicing our non-consent to past, present and potential future treasonous activities as our collective silence is being wrongly taken to be consent
- 10. We the people are the true sovereigns under the law of the land and ancient custom. Government derive authority strictly from we the people and serve us under their Oath of Office
- 11. We the people are increasingly having our unalienable rights under Common Law trampled on by treacherous legislation and its enforcement by Officers who are ignoring the Law and instead applying corporation-centred and corporation sponsored rules (Case Studies Three to Seven in Part Two of the Notice)
- 12. We are now in a state not just of treason, aided and abetted by official malfeasance, misfeasance and nonfeasance in public office, but of moral and humanitarian emergency
- 13. Good men and women are losing their homes, their livelihoods and in many cases their lives as a result of treacherous breaches of duty of care owed to them by officers. This has to stop immediately.
- 14. Predatory mega-corporations and globalist agendas applied locally are believed to be the root cause of this cancerous growth in society: see Earth Summit Agenda 21 [United Nations 1992]
- 15. Treasonous activity by previous governments (Blair and Cameron) are included as well as the more detailed history and legal implications of the signing of the Treaties of Rome and Nice (Case Studies One and Two in Part 2 of the Notice)
- 16. Finally it is an appeal for the restoration of Constitutional Common Law, jurisdiction being returned to the people for morally correct self-governance
- 17. It provides a reasonable time frame to the Chief Officers to respond to the Notice in honour with appropriate rebuttals or be deemed at law to accept the allegations and evidence contained in it
- 18. Chief Constables are requested to state their allegiance once and for all: to the megacorporations under unlawful legislation or to we the people under Constitutional Common Law.
